TENDER SCHEDULE FOR THE PURCHASE OF SCRAP MATERIALS

Wax sealed tenders are invited from the interested parties for purchase of scrap materials from this company on "**as is where is basis**".

1) DESCRIPTION OF SCRAP MATERIALS AVAILABLE:

(a) Gold thread Waste: -

Approximate quantity available 1000 kgs, the Gold thread waste among other things contains Gold, Silver and Silk.

(b) Silver thread waste: -

Approximate quantity available 85 kgs, the silver thread wastages among other things contain Silver and Silk.

(c) Red silk waste: -

Approximate quantity available 20 Kgs, the Red silk wastage's mingled with small traces of Silver wire.

(d) Silver Chloride: -

Approximate quantity available 22 Kgs. The Silver Chloride among other things contains, Silver.

(e) Testing Lab waste:

Approximate quantity available 13 Kgs. The Testing Lab waste among other things contains Silver, Gold and Silk.

(f) Silver Wire:-

Approximate quantity available 75 Kgs. It contains Silver and Copper.

2. SUBMISSION OF TENDER:

The tenders should be styled as notified and submitted in sealed cover, so as to reach the Managing Director, Tamil Nadu Zari limited within the stipulated date and time. The Tender (sealed cover) must be superscripted as " Tender for purchase of scrap materials". The tender should be submitted in two separate covers Superscribing cover "A" and cover "B" as detailed below:-

The Cover "A" should contain the following Documents:-

- a) Proof of actual trader.
- b) Proof of Income Tax PAN and filling of Income Tax returns.
- c) Proof of Sales Tax Registration Certificate TNGST / CST
- d) EMD of Rs.1,50,000/- by Demand Draft in favour of Tamil Nadu Zari Ltd., payable at Kancheepuram.
- e) Affidavit that the firm is not blacklisted by State/Central Government Departments or affiliated units.
- f) Duly signed terms and conditions for purchase of scrap materials.

If any one of the documents from (a) to (e) is not accompanied with the tender, it is invalid.

The cover "B" should contain price quotation.

3) RATE: -

- a) Rate shall be quoted per kg weight of each scrap material but exclusive of sales tax, surcharge on sales tax, CST. The local sales tax, Surcharge on sales tax., CST should be specified separately.
- b) Tender will be awarded to the highest bidder in each category of scrap. If the rates quoted by the tenderers is below the Company's internal assessment value of the scrap materials, the tenderer will be called for negotiations before the Committee.

4) TNGST/CST/TCS :

The rates quoted should be exclusive of Sales tax applicable in the State of Tamil Nadu. The TNGST/CST is applicable as per Act. Apart from Rate and applicable Tax Collection at Source (TCS) will be collected as per Income Tax Act. If the Tenderer is from outside the State they must produce the copy of the CST Registration, etc. in cover 'A'.

5) PLACE OF DELIVERY:-

Tamil Nadu Zari Limited, Industrial Estate, Orikkai, Kancheepuram 631 502.

6 TIME OF DELIVERY:

The successful tenderer should clear the materials by Demand Draft in favour of Tamil Nadu Zari Limited, Kancheepuram within 10 days time from the date of intimation (i.e. award of contract). In the event of the successful tenderer backing out, any loss to the Company arising on the sale of scrap at a lower price subsequently would be recovered from him. Apart from this the EMD along with Security Deposit will be forfeited.

7) EARNEST MONEY DEPOSIT AND SECURITY DEPOSIT: -

All the tenderers shall pay an Earnest Money Deposit of Rs.1,50,000/- (Rupees one lakh and fifty thousands only) along with the Tender. The Demand Draft should be in favour of Tamil Nadu Zari Limited, Kancheepuram. The tenders not accompanied with the Earnest Money Deposit shall summarily be rejected. For the successful tenderers, apart from the Earnest money deposit of Rs.1,50,000/- a security deposit of Rs.7,50,000/- should be paid with 2 days from the date of intimation. The EMD of the successful tenderers and the Security Deposit received will be adjusted in the last bill. The Earnest Money Deposit of the unsuccessful tenderers will be refunded as per Rules, as soon as the offers are finalised. EMD will not be accepted in cash or cheque. The amount remitted towards EMD and Security Deposit is liable to be forfeited in case the tenderer withdraws from his offer after submitting his tender or after his offer is accepted by Tamil Nadu Zari Limited, the tenderer fails to execute an agreement /contract within the prescribed date.

8 PLACE OF RECEIPT OF TENDERS:

Cover "A" and Cover "B" should be wax sealed and placed in another Envelope and wax sealed cover superscribing "Tender for purchase of scrap materials" and addressed to

9 OPENING OF TENDER:

The sealed tenders will be received upto 11.00 A.M on 13.03.2009. For opening of Tenders is fixed on 13.03.2009 at 11.30 A.M.

The award of the contract shall be made within 3 days time after opening of tenders with the successful tenderer.

10. The successful tenderer should submit a Bank Guarantee in favour of Tamil Nadu Zari Limited, Kancheepuram to the total value of the scrap materials before lifting the scrap materials within 5 days from the date of the intimation.

11. The successful tenderer should execute an agreement in the stamp paper worth of Rs.20/- for fulfillment of terms and conditions that he should clear the materials within 10 days time from the date of intimation (i.e. award of contract).

12. The tenderer should also produce the certification of TNGST/CST/GST confirming that he is a Registered dealer under the Commercial tax Department. If the eligible tenderer is firms out side the state they should produce the "C" Form at the time of delivery of materials.

13. The Managing Director reserves the right to accept or reject any tender without assigning any reason.

14. This tender Notification should be returned duly signed in all the pages along with quotations.
